

5-8 STANDARD (Grades 5-8)

Annual Tuition: 2026-27 Annual Tuition for 5-8 Standard (Grades 5-8) is **\$34,825**.

Sibling Discount: 2026-27 Annual Tuition is **reduced by \$2,000** for each additional child enrolled. The Sibling Discount is applied to each younger student and is only applicable when more than one child in the same family is enrolled during the same School Year.

Late Enrollment/Re-Enrollment: If a family enrolls after May 1st, 2026, on Payment Plan C, they will be responsible for all tuition payments scheduled up to the time of enrollment. These payments need to be made within 30 days.

Credit Card Fee: There is a 2.85% surcharge on all payments made by Credit Card. There is no additional charge for paying by eCheck.

³ The **Activities Fee** combines mandatory fees for payment convenience, such as term project week, certain field trips and/or events, the Communication Journal (CJ), and other costs. Please contact the School for specifics on what is included and excluded by grade level for the current school year.

⁴ The **New Student Fee** is a one-time administrative fee that covers the cost of setting up new students in our systems.

⁵ **TRP** is 4% of Remaining Annual Tuition (Annual Tuition less the Enrollment Deposit).

⁶ The **Processing Fee** applies to families on Payment Plan C (the 10 payment plan); it is an additional charge for the administrative cost of processing payments on a monthly basis.
